YOUTH HAVE ACCESS TO RESOURCES FOR BASIC NEEDS SUCH AS FOOD, CLOTHING, HYGIENE ITEMS, AND A SAFE SECURE PLACE TO BE DURING THE DAY. EDDY HOUSE ALSO OFFERS COUNSELING SERVICES, WORK FORCE DEVELOPMENT, LIFE SKILLS GROUPS, HEALTH CARE SERVICES AND MORE.
